Recently, Centre opened a new interactive gallery "Digital India" in the Centre, which is dedicated to various applications and uses of Digital Technology in India. In the same gallery, we are planning to open an experiential zone "Immersive Virtual Reality Theatre" for our esteemed visitors.

Brief note on system requirements and features:

This Tender outlines the SITC of a cutting-edge Virtual Reality (VR) theater at NSC, Delhi, designed to enhance the visitor experience and offer an innovative educational platform. The incorporation of a VR theater as an additional facility within the existing Science Museum aims to provide an immersive and engaging environment for patrons to explore and experience space sciences related concepts and discoveries in a captivating way.

The VR facility will consist of a synchronized VR system with **two** distinct modes of operation. **The facility should include 20 VR chairs/seating arrangement with wired/wireless headsets, and server console with a PC for control and management.** The VR chairs should support the 3DOF (Three Degrees of Freedom) movement, providing an immersive and interactive experience.

Components

1. VR chairs/seating arrangement (20 units)

- Ergonomically designed seating arrangements/chairs
- Equipped with wired/wireless headsets.
- Supports 3DOF controlled movement.
- High-quality image resolution for an immersive experience.
- This should have capacity to hide all mechanical and IT related equipment (Streaming PC, Motor etc.)
- 2. Server Console (1 unit)
 - High-performance PC for content management and system control.
 - Central control unit for synchronization and operation modes along with and storage.

Modes of Operation

- 1. Synchronized Playback Mode
 - **Description**: A single content played from the server and synchronized across all 20 VR headsets.
 - **Movement Synchronization**: All headsets will experience the same 3DOF movements in sync with the played content.

- **Individual Movement Synchronization**: Each headset will have its own synchronized 3DOF movement based on the specific played content.

 - The system designed to be scalable, allowing for the addition of more VR Chairs/ seating arrangement, if required, in the future.



* In this document, Similar Works refers to the design and development of VR-based theaters (either standalone or server-client based) for venues such as museums, tourist centers, business centers, etc.

Joint Venture (JV) Experience: If the experience is attributed to a JV, it will be considered only if the same JV participates in the project.

Individual JV Member Participation: If one of the JV members participates individually or with a different partner, the relevant experience will only be counted based on the Memorandum of Understanding (MOU) or deed between the JV partners, which must clearly outline the percentage or scope of work completed by each partner.

Eligibility Criteria for Applying:

Agencies / production houses that are fulfilling the following conditions will be eligible for submission of E-Tender:

i. The bidder could be an Individual, Limited Company/Corporation, Proprietary Firm, Partnership Firm/Company etc. Consortium or Joint Venture are allowed to bid for the Works.

- *ii.* The bidder should have minimum experience of 05 years preceding the proposal due date, in the similar field of works.
- *iii.* The registered company/firm should have a well-equipped and trained production team, having graphics, VFX Animation Studio etc. (well built-up infrastructure) and in-house VR content development team.
- iv. Firms/Companies should have an average annual financial turnover of ₹190 lakhs over the last three financial years. To calculate this average turnover, the best three years out of the last five financial years will be considered (2019-2020, 2020-2021, 2021-2022, 2022-2023, and 2023-2024).
- v. The Bidder should have the requisite work experience of completing similar projects during the last 5 years preceding the proposal due date as per the details given below:
 - (01) One similar work of value not less than ₹ 80% of the estimated cost of work.

or

(02) *Two similar works* each of value not less than \gtrless 60% of estimated cost of work.

or

(03)*Three similar works* each of value not less than ₹ 40% of estimated cost of work

- *vi.* The bidder should provide documentary proof for the above in the form of a work order / supply order / contract document and completion report/testimonials for completion.
- *vii.* <u>*The Bidder Should fill up all related Annexures (Specially complete BOQ and Annexure K (a) and K(b) with proposed make and model for each equipment)*</u>
- viii. The bidder should submit the Proof of concept (PoC) document i.e. draft Scheme with Drawing and design of the entire space along with system, mentioning different possible interactivity.

N.B Even though the bidders meet the above qualifying criteria, they will be subject to disqualification if they have:

A. Technical Evaluation

- i) The Evaluation Committee appointed by the Centre shall carry out its evaluation applying the evaluation criteria specified in the bid document. - <u>Modes of Operation Synchronized Playback Mode Description:</u> A single content is played from the server and is synchronized across all 25 VR headsets. Movement Synchronization: All headsets will experience the same 3DOF movements in sync with the content being played. Use Case: Ideal for group demonstrations where all participants view and experience the same content simultaneously.
- 8. <u>Independent Playback Mode Description</u>: Different content can be selected and played on each VR headset independently from the server. 



Drawing and dimension of proposed VR theatre







